	<ul> <li>a. HSLB will provide a designated research space with prepared artifacts.</li> <li>b. No food or drink allowed in designated research space.</li> <li>c. HSLB is not responsible for any personal belongings left unattended.</li> <li>d. Researchers must not be disruptive. Headphones must be worn if sound is used on any electric device.</li> <li>e. HSLB reserves the right to end research appointments at any time. Appointments may be rescheduled at the discretion of HSLB.</li> </ul>
2.	f. Use of ink pens is prohibited while collections are present.  Handling Guidelines
	<ul> <li>a. Gloves are required for all collection handling.</li> <li>b. HSLB provides gloves for use by researchers and staff.</li> <li>c. Availability and or handling of items is at the discretion of HSLB, based on item's fragility, or historical value.</li> <li>d. Fragile or rare items requiring extra care may require an additional fee due to limited resources.</li> <li>c. Collections must be handled with ears. Do not place anything on top of collection items.</li> </ul>
•	<ul> <li>e. Collections must be handled with care. Do not place anything on top of collection items.</li> <li>f. Do not bend, write on, or modify collection items in any way.</li> <li>g. Collections used by the researcher should not be left unattended. Researchers must notify a staff member when leaving research space.</li> <li>h. Designated research space must be cleaned, and materials put away at the end of use. Researchers may request assistance.</li> </ul>
3.	Photography  a. Photography Fees i. Cellphone/table photography of non-photographic items for reference only (bibliographic reference, student papers, professional reports scholarly articles) is included with research fee. ii. Publication and any other use require a Rights and Reproductions Agreement b. Flash photography is prohibited.
	<ul> <li>c. DSLR or film photography of a single piece on display, documents, or otherwise is prohibited.</li> <li>d. Items on display—photography of a single image is not permitted, photography of a group of images is permitted and can be posted on social media with attribution to HSLB.</li> </ul>
١.	<ul> <li>e. Photography of single images is prohibited. A water-marked, low resolution image may be purchased with Rights &amp; Reproduction Agreemen price depends on use</li> <li>Publication</li> </ul>
	<ul><li>a. All publication or other use of HSLB materials is at the discretion of HSLB Staff.</li><li>b. All publication of HSLB materials require a Rights &amp; Reproductions Agreement and fees paid in advance.</li></ul>
5.	<ul> <li>Reproduction of Photographic Materials Fees &amp; Guidelines</li> <li>a. Images may be used in student papers for \$25 with bibliographic citation.</li> <li>b. Images by be used in a professional publication for a \$50 fee with bibliographic citation.</li> <li>c. Reproductions, cell phone photography, and scanned reproductions are made at the discretion of the Executive Director or staff on a case by case basis.
